## GYMNASTICS AUSTRALIA NATIONAL RISK PROTECTION PROGRAMME

The Gymnastics Australia National Risk Protection Programme ("The Programme") is a joint initiative of Gymnastics Australia and its State Associations and has seen a number of benefits provided to gymnastics clubs throughout Australia. It is designed to save clubs time, effort and money, and provide enhanced cover and services for the gymnastics community.

### Coverage

This Programme provides coverage 365 days of the year with an annual renewal date of 31st December.

### What's Covered

In general, all gymnastics activities are covered. This includes competitions, training, functions, meetings and the like (anywhere in Australia). The Programme provides competitively broad protection across the following areas:

##### Who is Covered?

Gymnastics Australia Limited, all State Associations, Legal Entity Clubs and Associations affiliated directly or indirectly with Gymnastics Australia, including most club individuals and guest gymnasts (whilst participating in officially organised events).

###### General Liability

Public Liability - \$20,000,000 (\$1,000 Excess)  
Professional Indemnity - \$10,000,000 (\$1,000 Excess)

###### Management Liability

Directors & Officers - \$5,000,000 (Nil Excess - in part)  
Employment Practices - \$5,000,000 (\$5,000 Excess)  
Employee Theft - \$25,000 (\$2,500 Excess)

##### Who is Covered?

All employees, staff, registered members and non-participating officials including coaches, judges, voluntary workers, club committee members, office bearers, medical officers, prospective gymnasts (for up to 4 weeks after initial approach) and guest gymnasts in official events.
