Where covered expenses cannot be provided during the policy's usual twelve (12) calendar month benefit period and the delay with treatment is recommended by the Insured Person's treating medical practitioner, specialist or dental surgeon and is entirely due to the original injury, then these expenses will be paid provided the original injury/claim was lodged within the Policy Period and a medical statement is provided which confirms the date the treatment/procedure can be undertaken. During this period the Insured Person must follow medical advice from his or her legally qualified medical practitioners or qualified medical dental surgeon. These expenses will be paid up to the maximum benefit payable under the policy and only whilst the policy remains in force.

In addition to the General Exclusions under the policy, cover also excludes claims arising from social end of season trips
